A1:	NUHS Fund Limited (NUHS Fund) is a Company Limited by Guarantee (CLG) and a registered charity with Institute of Public Character (IPC) status. Managed by the National University Health System (NUHS), NUHS Fund supports research, education, and patient programmes to fulfil NUHS' vision of shaping medicine to transform care for a healthy community.
	Gifts directed to NUHS Fund contribute to achieving the following objectives:  a) To improve health in Singapore; and b) To develop a future-ready Health System, including the health workforce, innovations, technology and new models of care to ensure better health outcomes for the Singapore community.

## Q4: What regulations does NUHS Fund operate under?

A4: NUHS Fund is governed by The Companies Act, The Charities Act, The Personal Data Protection Act, Inland Revenue Authority of Singapore Regulations and Singapore Police Regulations. NUHS Fund also reports to the Sector Administrator, Ministry of Health.

As an IPC under the Charities Act, NUHS Fund is committed to maintaining the highest standards of governance provided by the Commissioner of Charities.

## About 'Gift of Hope'

## Q1: Why should I contribute to the 'Gift of Hope' cause?

A1: The harsh reality is that medical expenses and rehabilitation costs can be overwhelming - even for those with insurance or those who are eligible for various public assistance schemes. This financial burden can exacerbate health issues, creating a vicious cycle of illness and economic strain.

While the government has been expanding help to patients who require financial assistance, there are exclusions from Medifund and Medishield Life which include consumables, home assist equipment, step-down care, out-patient consultations, medication as well as procedures and treatments still not considered standard of care.

NUHS Fund supports gaps not covered by government support or other public assistance schemes. Your 'Gift of Hope' will directly impact the lives of individuals and families facing the dual challenges of health issues and financial hardship.

Every dollar donated will be used in its entirety to support patients in need of financial aid in the following ways:

- Access timely and vital medical treatments and therapies.
- Receive essential medications and necessities related to their condition.
- Undergo rehabilitation and step-down care in the community.

# Who are the beneficiaries? A3: Majority of applications to NUHS Fund come from the lowest 20% Per Capita Income (PCI) of the Singapore community, measured by Department of Statistics (Household Income), 2021.

Please refer to our Donor report for details.

## Q4: Do the beneficiaries include foreigners?

A4: As an IPC charity, all tax-deductible donations must be channelled towards benefitting the Singapore community which includes:

- Singapore Citizens
- Permanent Residents
- Resident Foreigners

On a limited basis, we are allowed to assist non-resident foreigners under the Charities Act and the source of donations to support this does not receive tax-deductibility.

## Q5: How does the charity decide which patient gets funding?

A5: All patient applications to NUHS Fund are reviewed by a Medical Social Worker (MSW)/Social Worker (SW) who will perform a financial assessment and make a recommendation for approval.

Patients must be subsidised patients at NUHS entities or partner organisations who fulfil the requirements of the sub-funds. The amount of help received from the charity will vary depending on the individual circumstances, the patient's financial background and the financial cap criteria for respective sub-funds.

#### Q6: Are there other avenues of funding available to these individuals and families?

A6: Yes, there are. MSW/SW will explore all available funding schemes including government (Medifund/ Medishield Life) and other public assistance schemes or charities before tapping on NUHS Fund.

Generally, funding from NUHS Fund is the last resort after all other avenues of funding have been exhausted.

Under some circumstances where external applications undergo a lengthy process of review and approval and where the condition of the patient may be compromised, the charity's monies may be tapped on in the first instance.

Q2: As an IPC charity, tax-deductions can be issued for eligible donations of \$10 and above (unless A2: otherwise stated in specific campaigns). Tax-deductions will be issued only if required information is provided. Examples of instances where tax deduction will not be provided include: Donations supporting individual patients specified by the donor. Donations supporting non-resident foreigners. Donors will either receive a tax-deductible receipt or a non-tax deductible receipt as an acknowledgement of donation. Where donations are collected via collaborations with partners and information of donor is not collected, NUHS Fund will not be able to provide any acknowledgement receipts. How much of my donation goes towards the cause? Q3: A3: Unless otherwise indicated in specific campaigns, every dollar donated to NUHS Fund is channelled in its entirety to support the causes per donor's intent. NUHS Fund incurs minimal administration costs as all manpower overheads are absorbed in the budget of NUHS DO and operating costs such as bank charges, administrative charges by online platforms (e.g. Giving.SG, Give.Asia) and audit fees due to annual statutory requirements are covered by ring-fenced funds. NUHS DO also does not engage commercial third-party fundraisers.
