Aufa, a 14-year-old with Down Syndrome, suffers from pulmonary stenosis and regurgitation from post-tetralogy of Fallot repair, which makes it harder for his heart to pump blood effectively. His doctors recommend a new pulmonary valve procedure due to expected progressive deterioration in his right ventricular function.

The eldest of three children, Aufa attends a special needs school. His parents face significant financial burdens, including Aufa's medical bills, specialist fees for his youngest sister who has developmental delays, and dialysis treatments for both paternal grandparents. These expenses have strained the family's finances, making it challenging for them to make ends meet.

With the support from the NUHS Fund and generous donors, Aufa's family received the assistance they needed. Aufa has successfully undergone the procedure and is now on the road to recovery. He has returned to school and is gradually resuming his basketball practices. His family hopes he can continue to stay active and enjoy the activities he loves.
